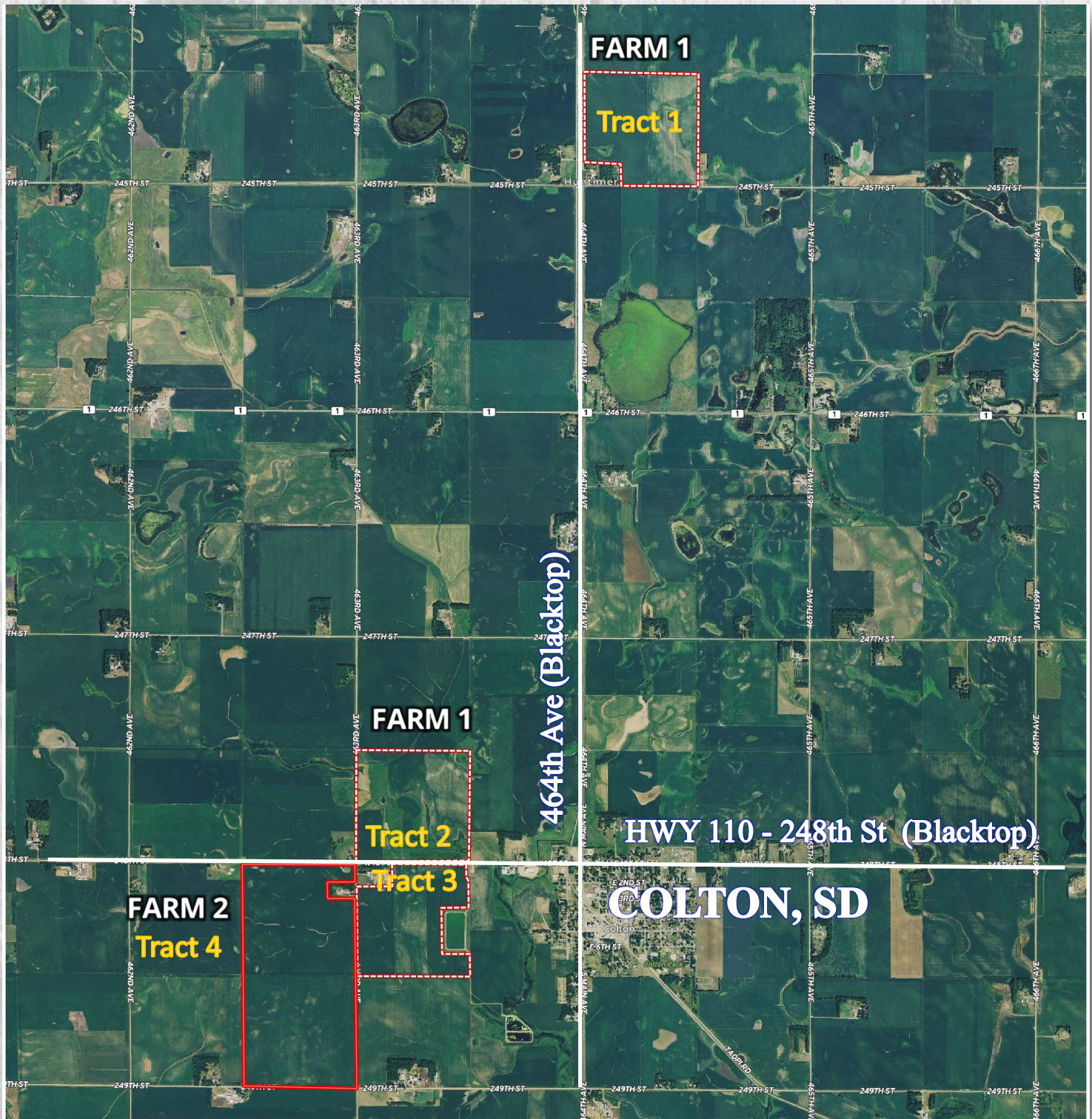

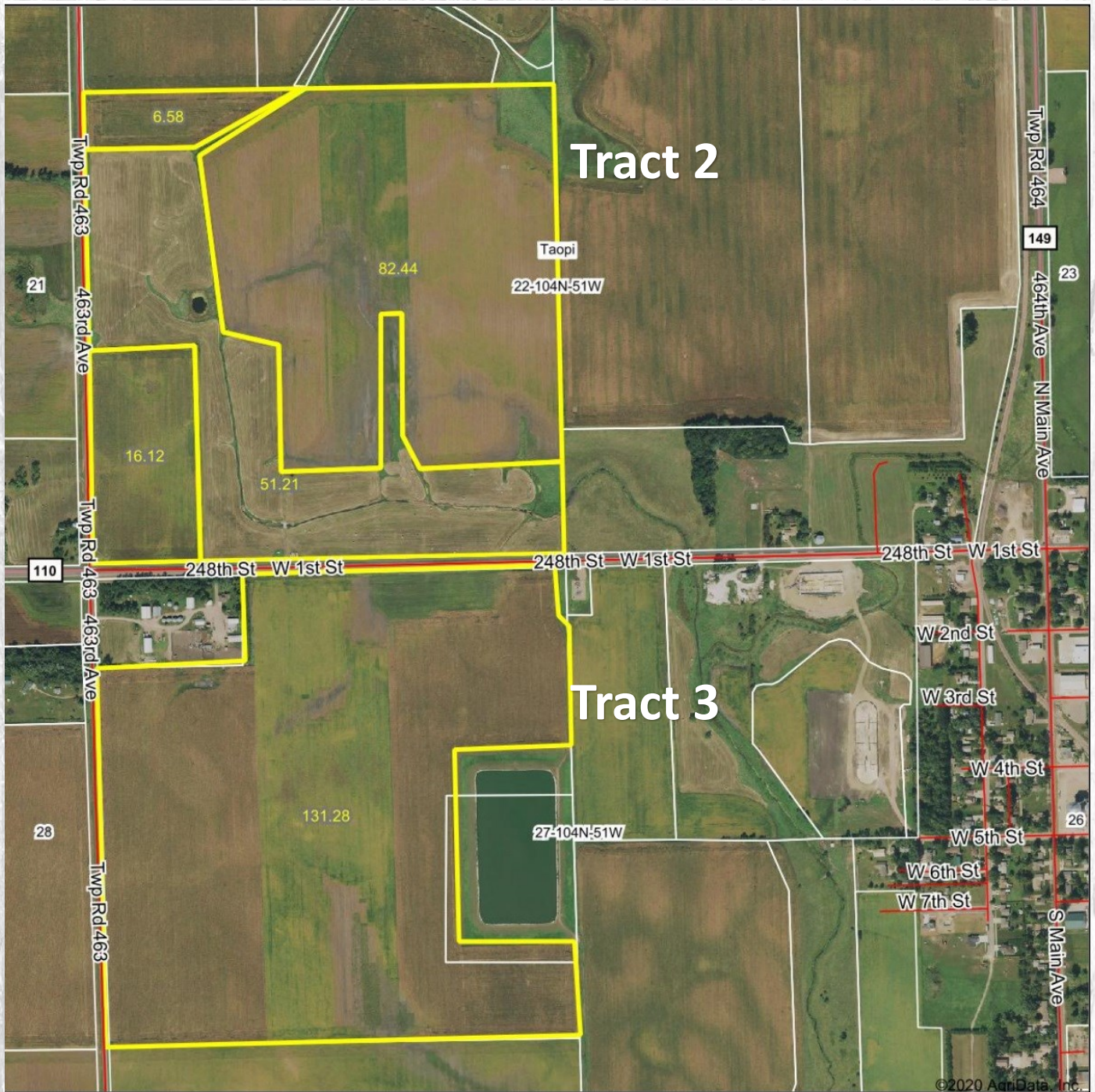

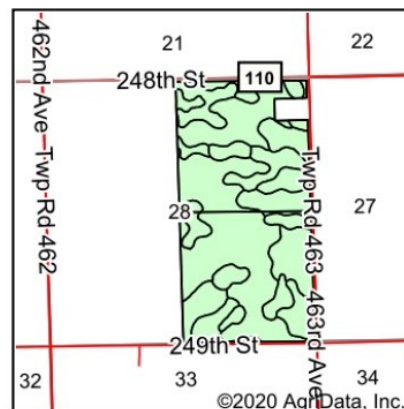
Tract 4
