Durward Ratzlaff of 20725 336th Avenue, Highmore, South Dakota 57345, in consideration of One Dollar (\$1.00), receipt of which is acknowledged, is the owner of the Northwest Quarter (NW¼) of Section Twenty-six (26) and the Northeast Quarter (NE¼) of Section Twenty-seven (27) in Township One Hundred Eleven (111) North, Range Seventy-two (72), West of the 5th P.M., County of Hyde, State of South Dakota, and aware of the benefits of maintaining a certain well and water line under the responsibility and supervision of Durward Ratzlaff, as hereinafter described, does hereby convey and release to:

Elroy Ratzlaff and Donita Ratzlaff, husband and wife, of 20650 335th Avenue, Highmore, South Dakota 57345, owners of the West Half (W½) of Section Twenty-seven (27) in Township One Hundred Eleven (111) North, Range Seventy-two (72), West of the 5th P.M.;

Alvin Gibson of 417 Parker Avenue SW, Highmore, South Dakota 57345, owner of a life tenancy interest; Anna Mae Ryan of 1325 Sun Court, Lancaster, California 93535; Sharon K. Wilson of 108 East St. Andrews Drive, Sioux Falls, South Dakota 57108, and Gary Gibson of 20611 334th Avenue, Highmore, South Dakota 57345, owners of the remainderman interest; of the Northwest Quarter (NW¼) of Section Twenty-eight (28) in Township One Hundred Eleven (111) North, Range Seventy-two (72), West of the 5th P.M.; and

Allen Gibson and DeVandolyn M. Gibson, husband and wife, of 20643 335th Avenue, Highmore, South Dakota 57345, owners of the Northeast Quarter (NE¼), less the Northeast Quarter of the Southeast Quarter of the Northeast Quarter (NE¼SE¼NE¼), of Section Twenty-eight (28) in Township One

Hundred Eleven (111) North, Range Seventy-two (72), West of the 5th P.M.; an easement and right of way to a certain well and water line, hereinafter more particularly designated and described, over and across land owned by Durward Ratzlaff and situated in the County of Hyde, State of South Dakota, as shown by the attached map marked as Exhibit "A" which is incorporated herein, and more particularly described as follows:

The Northwest Quarter (NW¼) of Section Twenty-six (26) and the Northeast Quarter (NE¼) of Section Twenty-seven (27) in Township One Hundred Eleven (111) North, Range Seventy-two (72), West of the 5th P.M.

The parties hereto agree and understand that Elroy Ratzlaff owns the $W\frac{1}{2}$ of 27-111-72 and that Elroy Ratzlaff will be allowed to install a waterline from Durward Ratzlaff's water tank located in the middle of the above described $NE\frac{1}{4}$ of 27 west to the middle of the described $NW\frac{1}{4}$ of 27 to a water tank to be installed by Elroy Ratzlaff as well as a waterline south to a water tank to be installed by Elroy Ratzlaff in the north part of the described $SW\frac{1}{4}$ of 27 as shown by the attached aerial map marked as Exhibit "B" which is incorporated herein.

The parties further acknowledge and agree that Alvin Gibson, Anna Mae Ryan, Sharon K. Wilson, and Gary Gibson own the NW¼ of 28-111-72 and that Allen Gibson owns the NE¼ of 28-111-72 and that Gibson's will be allowed to install a waterline from Elroy Ratzlaff's water tank that is to be installed in the middle of the described NE¼ of 27 west to a water tank to be installed by Allen Gibson in the middle of the above described NE¼ of 28 and proceeding west by a waterline to be installed by Alvin Gibson to a water tank to be installed by Alvin Gibson in the middle of the described NW¼ of 28 which shall over flow by a waterline to be installed by Allen Gibson to a nearby dugout in the described NW¼ of 28 as shown by the attached aerial map marked as Exhibit "C" which is incorporated herein.

The present and existing well on the described Northwest Quarter (NW½) of Section Twenty-six (26) in Township One Hundred Eleven (111) North, Range Seventy-two (72), shall be repaired and maintained by the party who does the repair and maintenance on said well. However, none of the parties to this agreement shall be required to repair said well in the event said well quits working. As to the repair and maintenance of the waterlines, the parties hereto agree and acknowledge that the repair and maintenance of the waterlines as shown on the attached Exhibit "A" shall be the responsibility

of Durward Ratzlaff; that the repair and maintenance of the waterlines as shown on the attached Exhibit "B" shall be the responsibility of Elroy and Donita Ratzlaff and that the repair and maintenance of the waterlines as shown on the attached Exhibit "C" to the water tank in the NE¼ of Section 28 shall be the responsibility of Allen Gibson, and that the repair and maintenance of the waterlines as shown on Exhibit "C" from the water tank in the NE¼ of Section 28 to the water tank in the NW¼ of Section 28 and onto the dugout shall be the responsibility of Alvin Gibson, Anna Mae Ryan, Sharon K. Wilson and Gary Gibson.

The right of way hereby conveyed and released is for the sole purpose of said well and waterline over and across the above described NW¼ of 26-111-72 and NE¼ of 27-111-72 and the need for such waterline has been determined by the said landowners, with the route and course of the said waterline running in a westerly direction across the described NW¼ of 26 and to the point where it now ends in the NE¼ of 27. All parties are in agreement that it is to their benefit to extend this waterline across the described W½ of Section 27 and the described N½ of Section 28 as set forth herein, to four additional water tanks; (two located in the W½ of Section 27 and two located in the N½ of Section 28); as shown by the attached USDA/NRCS aerial maps marked as Exhibits "A", "B", and "C" which are attached and made a part hereof.

In further consideration, the parties shall have access to said waterline and use of water, if Durward Ratzlaff's well is functioning and there is sufficient water supply for both Durward Ratzlaff and the other parties' uses. If the well in the NW¼ of 26-111-72 goes bad or water pressure drops to less than 30 gallons per minute, then Durward Ratzlaff shall be allowed to shut off the water to said remaining parties and their water tanks without any liability or penalty to Durward Ratzlaff.

The easement described herein is to and shall run with the land, and shall be for the benefit and use of Elroy Ratzlaff and Donita Ratzlaff, husband and wife; Alvin Gibson; Anna Mae Ryan; Sharon K. Wilson; Gary Gibson; Allen Gibson and DeVandolyn M. Gibson, husband and wife; their heirs, assigns and successors.



Plan Map Grazing Land


